 - 5.1 **TA/2020/1607/TCA** - 10 to 21 Stychens Close, Bletchingley RH1 4NY - Conifers on bank - Fell Self-seeded Sycamore - Fell to ground level. Overhanging Sycamores - Overall crown reduction of approximately 20% volume, away from buildings and overhead cables whilst maintaining shape. (AD)

TA/2019/2147 - Mercers South Quarry, Bletchingley Road, Nutfield, Surrey RH1 4EU - The extraction and screening of sand from Mercers South with progressive restoration to agriculture using inert waste materials, together with associated infrastructure, on a site of 52.2ha and the temporary diversion of public footpath 173 for the duration of the operations without compliance with Condition 8 of planning permission ref: TA/2019/34 dated 6 June 2019 so as to allow revision to the numbers of HGV movements. **GRANT – dated 10/09/20.**
